

**NORTHBRIDGE PLAZA CAVIAR GIVEAWAY**  
**TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is Northbridge Plaza, 79-113 Sailors Bay Road, Northbridge, NSW, 2063 AMP Capital Shopping Centres Pty Limited (ABN 13 001 595 955) of 33 Alfred Street, Sydney NSW 2000 AUSTRALIA telephone **02 9398 9099** ("**Promoter**").
3. Entry is only open to Australian residents aged 18 years or over.
